

Debbie McMillin Memorial Preschool Scholarship

Debbie McMillin, a dedicated preschool teacher, was loved dearly at East Hills Preschool. Throughout her years at East Hills (1979-2006) she contributed to the lives of more than 2,000 children. In loving memory of Debbie's dedication to the children, East Hills Preschool has established the Debbie McMillin Scholarship Fund. This scholarship is available annually to eligible children whom would not otherwise have the opportunity to attend preschool due to financial hardship.

Scholarships are financed with regular tuition fees and donations. The school may also, from time to time, solicit funds to offset the cost of the scholarship program. Donations may be made to the Debbie McMillin Scholarship Fund at any time.

Scholarship Goals:

1. To provide preschool experience for children starting kindergarten in the next school year, whose family can not afford full preschool tuition fees.
2. To further our founding mission of providing for the young children in our community, a superior learning opportunity within a stimulating and loving environment.
3. To help ensure economic and social diversity within the student body.

Scholarship Recipient Responsibilities:

Scholarship families are asked to fulfill their East Hills committee and snack responsibilities outlined in the East Hills Parent Handbook. The Scholarship committee can waive this requirement in part if it presents an undue hardship for the family.

Scholarship Application Process:

There will be a notice of availability of scholarships on the regular application form sent to all prospective parents. If a family expresses interest in a scholarship, a scholarship application form will be sent by the Director of East Hills Preschool. The deadline for receipt of scholarship applications is June 30th for fall admission and October 31st for spring admission. The Scholarship Committee, selected by East Hills Board of Directors, will meet after that date to select scholarship recipients and will notify them in writing if a scholarship is awarded. The scholarship recipient must sign and return the scholarship award notification, thereby agreeing to the terms and conditions of the scholarship. The registration fee for all scholarship applicants will be waived initially. However, if a scholarship is not awarded and the family still wishes to enroll, the registration fee must be paid in full upon enrollment.

1. A completed scholarship application must be submitted to East Hills Preschool Director by June 30th for fall admission and by October 31st for spring admission.
2. Registration with Santa Clara County 4Cs, www.4c.org, is necessary to be placed on an eligibility list for the scholarship. East Hills will initiate the process with 4Cs and interested families will be contacted by phone to complete registration.
3. Two recent pay stubs and the most recent tax return must accompany the application to verify family income.
4. The Scholarship Committee will review application information and determine scholarship awards by July 31st for fall admission and by November 30th for spring admission.
5. All information received during the application process will be used by East Hills Preschool strictly for determining eligibility for the scholarship.

Scholarship Selection Criteria:

1. Financial need is a prerequisite for scholarship eligibility based on availability of funds.
2. The selection committee will use the income guidelines established by the California Department of Education and Child Development Division, www.cde.ca.gov, to determine eligibility for scholarships. The current income guidelines are below, to be considered for a scholarship the monthly family income must fall between the minimum and maximum amounts:

* Special programs are offered through 4Cs for families below the minimum monthly family income.

3. Pre-Kindergarten children, 4 to 5 years of age, are eligible for the scholarship based on financial need.
4. Priority will be given to pre-kindergarten children who have been on the 4C’s Santa Clara County waiting list (CEL) for the longest duration.
